"FRONTSTEPS: A RESIDENT'S GUIDE"

The Recreation Board is launching a new website through our management company, Citadel Property Management Group. As it develops, this website will contain valuable information concerning the recreation facilities and activities here at Village on the Green. In the upper right corner click on "sign up" and follow the instructions to set up a logon password.

CONDO III BOARD UPDATES

Guidelines When Leaving Your Property: Always turn off the water to your unit whether leaving for a few days or longer. The shut-off valve is outside your unit, in most cases on the wall under your front bedroom window. Those in 2-story condos will find the shut-off valve on the left for downstairs, on the right for upstairs. It is also recommended that the water to the washing machine, toilets and sinks be turned off. The hot water heater can be turned off at the breaker. Electricity should always be left on. Set the AC no higher than 82 degrees. This is imperative to avoid buildup of mold and mildew inside your unit and perhaps in adjoining units. Leave a key with a friend, neighbor or Board member and have them check your unit every couple of weeks.
